### **ORDER:**

In the reference 1<sup>st</sup> cited, the Sree Abirami College of Pharmacy, Coimbatore has obtained Government Order from Health and Family Welfare (PME-2) Department, Tamil Nadu to conduct B.Pharm Degree Course.

2. In the reference 2<sup>nd</sup> cited, the University has granted the Provisional Affiliation order to **Sree Abirami College of Pharmacy, Machegondapalayam, Seerapalayam Village, Eachanar Post, Coimbatore – 641 021**, for conducting the B.Pharm Degree Course with an annual intake of 50 seats from the Academic Year 2017 - 2018.



3. In the reference 3<sup>rd</sup> cited, the University has granted the revised Provisional Affiliation order to Sree Abirami College of Pharmacy, Coimbatore for conducting the B.Pharm Degree Course with an annual intake of 60 seats from the Academic Year 2017 – 2018.

4. In the reference 4<sup>th</sup> cited, the Hon'ble High Court of Madras has passed a order dated 17.07.2018 passed in W.P. Nos.16464, 16651 and 17085 of 2018 by Hon'ble High Court of Madras and the operative portion of the Court order held as follows:

“.....13. It is for the 1<sup>st</sup> Respondent / University to ascertain as to whether the Petitioner / Institutions have complied with the norms and thereafter, consider the request of the Petitioner / Institutions for affiliation. Rejection of grant of affiliation to the Petitioner / Institutions on the ground that their request for annual intake from 60 to 100 will be considered only after the successful completion of Course by the first batch of students, may not be correct.

.....14. If sufficient infrastructure is available, the Petitioner / Institutions must be permitted to have an intake of entire 100 seats. If counselling is already over it is for the first Respondent / University to conduct the special counselling for the petitioner / institutions. However, the time limit prescribed by the Apex court in the case of Parshawant Charitable Trust vs. All India Council for Technical Education, reported in 2013 (3) SCC 385, should be taken note of for the academic years is question. It is made clear that if time is extended by the Apex Court subsequently, the name shall be taken note of by the 1<sup>st</sup> Respondent / University, while taking a decision with regard to the grant of affiliation to the Petition / Institutions for an intake of 100 students for the academic year 2018-2019.”

5. In compliance with the above stated Court order, an Inspection Commission was appointed to verify the infrastructural and other facilities for an annual intake of additional 40 seats. The report of the Inspection Commission as in reference 10<sup>th</sup> cited was scrutinised.




6, In the reference 10<sup>th</sup> the Governing Council has resolved, based on the orders of the Hon'ble High Court passed in W.P. 16464, 16651 & 17085 of 2018 dated 17.07.2018 and the Inspection reports to grant permission to Sree Abirami College of Pharmacy, Coimbatore for the increase of intake from 60 to 100 seats in B.Pharmacy Degree Course from the academic year 2018-2019.

7. In the pursuance of the above orders of the High Court of Madras and Resolution of Governing Council, the University grants Continuance of Provisional Affiliation to Sree Abirami College of Pharmacy, Coimbatore for conducting B.Pharm Degree Course for the academic year 2018 - 2019 as indicated below subject to the usual conditions already intimated in the Provisional Affiliation orders of this University.
